- 1. The rental cost for each 10'x 8' space is \$35.00. Pre-payment in full is required along with this completed and signed application and "Prohibited Items" sheet attached. (No refunds given)
- 2. Spaces for this event are limited and will be rented on a first come, first served basis. Spaces will be assigned before the event date and you will be notified via email of your designated space number.
- 3. This is an indoor event. One chair and one 6' table will be provided. Vendor must provide his/her own displays. Electricity is NOT available. If additional table space is required, vendor is permitted to bring another table, but it must fit within the 10'x 8' space provided, or multiple spaces must be purchased. (Please note: Each "Space" will have 10' of frontage with vendors on either side of you.)
- 4. Vendor's merchandise must be original and handcrafted, or product purchased through a reputable distributor or party plan. (i.e, Companies such as, but not limited to; Avon, Premier Designs Jewelry, Lularoe, Tupperware, Mary Kay, etc...). No kits or resale items allowed and we reserve the right to judge which fine arts/crafts, and merchandise are allowed in this event. We also reserve the right to relocate vendors, if deemed necessary.
- 5. Set up time will begin at 8 am. *Do not arrive before 8 am as the doors will not be open yet.* Event will begin at 10 am and end at 6 pm. Vendors are respectfully requested to remain throughout the entire event. Reasonably priced food and beverages will be available at the kitchen, sponsored by Special Events Committee, or you can bring your own.
- 6. Vendor is required to keep his/her space clean and neat. All boxes, signs, trash and debris must be removed before vacating the space at the close of the event.
- 7. Vendor must accept full responsibility for any loss, injury or damage to persons or personal property that may be sustained while at the event. Buena Vista Township assumes NO responsibility.
