| <p>1. The rental cost for a 10'x10' space is \$30.00. This includes 10' of frontage, with vendors on either side. If more space is needed, multiple spaces must be purchased accordingly. <b>Pre-payment is required along with pages 1 &amp; 3 of this application completed and signed.</b> No spaces are reserved without the completed application and payment in full. No refunds given.</p>   |
| <p>2. All spaces will be rented on a first come, first serve basis.</p>   |
| <p>3. Vendor/Exhibitor must provide his/her own tables, chairs and displays. Electricity is NOT available. Since this is an outside event, some type of tent or canopy is recommended, and is not provided. Canopies cannot be staked down, only sandbag or weights are allowed.</p>  |
| <p>4. <b><i>Vendor's merchandise must be original and handcrafted, or product purchased through a reputable distributor or party plan. (i.e., Companies such as, but not limited to; Avon, Premier Designs Jewelry, Lularoe, Tupperware, Mary Kay, etc...).</i></b> No kits or resale items allowed and <b><i>we reserve the right to judge which arts/crafts, and merchandise are allowed in this event.</i></b> We also reserve the right to relocate vendors, if deemed necessary.</p> |
| <p>5. Set-up times will be approximately 2 hrs before the event starts, specific instructions will be emailed with the details; i.e., Space # assignments, set up times, and any additional information needed. <b>Unloading zones will be for unloading ONLY. Please do so in a timely manner and move your vehicle to the assigned vendor parking area BEFORE setting up your space.</b></p>  |
| <p>6. Vendor/Exhibitor is required to keep his/her space clean and neat. All boxes, signs, trash and debris must be removed before vacating the space at the close of the festival.</p>   |
